More information, along with payment amount and due dates, will be sent upon acceptance. Selected campers will be notified during the month of March.

Camper Requirements:

- * Must be able to enjoy themselves in a 1:6 staff-to-participant ratio.
- * Able to maintain a relatively high energy level for the duration of camp.
- * All participants must have a current Enrollment Form, Liability Waiver and Code of Conduct on file.
- * Appropriate & respectful behavior at all times.

Priority will be given to those who have stayed overnight successfully with TRS in the past. Any new campers will be required to come in for an interview and attend TRS programs before acceptance will be considered.

Financial Aid Opportunities:

1. We are in contact with Alta Regional Center to explore funding for this year's camps. If you are an Alta Regional Center client, please talk to your service coordinator to see if you qualify for this opportunity.

2. Pathways to Recreation, Inc. is offering camp financial aid to qualified individuals based on qualification.

Financial aid criteria:

- * Priority will be given to participants who can demonstrate financial need
- * Preference will be given for those who have never attended summer camps with TRS
- * Applicant must meet all camper requirements

Gibson Ranch Camp

Dates: Tues - Fri, May 21 - 24, 2024

Estimated cost: Day Camp \$500

Overnight \$650

Memorable activities, at least two meals a day, all supplies, camp shirt, and staff support

Held at the historic Gibson Ranch in Sac County, Gibson Ranch Camp can be a day camp or an overnight camp. During camp, there will be opportunities to visit the fishing hole, get to know the farm animals on-site, have a skit night, and much more!

Each morning will have an optional continental-style breakfast and will end with dinner together. There is VERY limited space for campers that may need overnight cabin accommodations, which will include an additional fee, and justification to be considered. However, at this camp, tent camping is welcomed and encouraged to accommodate more people!



Monte Toyon Camp

Dates: Sun - Fri, July 28 - August 2, 2024

Estimated Cost: \$1,250

Memorable activities, three meals a day, all supplies, camp shirt, lodging, transportation, and staff support

Monte Toyon is located in Aptos, among coastal redwoods, just south of Santa Cruz, CA. Campers sleep in cabin-style dorms at a beautiful residential camp.

The week at Monte Toyon is chock-full of unique summer camp traditions, as well as hiking among the redwoods and eating delicious home-cooked meals, all while escaping the Sacramento heat!
