Subject: **Permit for Gold Country Orienteers Special Event on the American River Parkway and Regional Parks Permitting Process Defects**

Dear Chair Peters and Board Members:

Your Board is identified in the American River Parkway Plan 2008 as the final authority regarding permits issued by your Regional Parks Department for special events and group activities on the American River Parkway. Accordingly, we are informing you of (1) our objection to the permit issued by your Regional Parks Department on March 7, 2013, allowing an "orienteering meet" to occur on the Parkway on September 15, 2013, and (2) our continuing objection to defects in the Regional Parks permitting process that has previously been described to you and your staff.

Attached are the results of our review of the subject permit and event. SARA became aware of this event after it happened and was contacted with a firsthand observation of the event in progress. Based on the firsthand account and subsequent review of the American River Parkway Plan 2008, the Findings in the attached conclude that the County violated state law by issuing a special event permit that is not consistent with the American River Parkway Plan 2008.

Regarding defects in the Regional Parks permitting process that we believe need to be remedied, please refer to our letter to you dated August 20, 2013.

The American River Parkway Plan 2008 requires the County to manage the Parkway to "ensure the protection of the Parkway resources, its environmental quality, and natural values." The County cannot meet this requirement without the mandated Resource Impact Monitoring Program. Furthermore, the County does not have the ability to issue a host of permits that are consistent with the American River Parkway Plan 2008 without the above mentioned mandated program because without adequate current knowledge of the natural resources it cannot determine that impacts from users and activities on the Parkway's "environmental quality" and "natural values" will be minimal.


