REGIONAL PARKS PASS STIPULATIONS

NO REFUNDS — NO REPLACEMENTS

- Passes are valid for a 12-month period from month purchased.
- Passes are valid for one vehicle entry only.
- A pass does not guarantee entry into parks that are full or closed for any reason, including inclement weather or flooding and is not valid for entry to special fee areas or special events.
- All passes must be displayed from the rear-view mirror or placed where they are visible from the vehicle's front exterior.
- Failure to display your pass may result in a citation for non-payment of fees.
- Verification of pass purchases cannot be made at fee stations. Visitors who do not have their pass in possession are subject to the daily entrance fee.
- Any unauthorized use of the pass will result in its revocation.
- Lost or stolen passes cannot be replaced and no refunds can be issued.
